





REPAIR PROCEDURE

- 1. Verify customer concern.
- 2. Remove center panel according to MS3 online instructions or Workshop Manual (section 09-20 CENTER PANEL UNIT REMOVAL/INSTALLATION).
- 3. Separate center panel and audio unit according to MS3 online instructions or Workshop Manual (section 09-20 CENTER PANEL UNIT DISASSEMBLY/ASSEMBLY).
- 4. Reinstall using new audio brackets (B and C) and screws (A and D) in reverse order of removal.



5. Install installation bolt (A) next to instrumentation panel bracket (B).



6. Verify repair.
