• 1997 vehicles produced before 1/13/97 (Miata) and 3/1/97 (Protege) did not have the capacity for Diagnostic Trouble Code (DTC) P0550, however, the air conditioning (A/C) inoperative condition is possible.


DESCRIPTION

Some vehicles may exhibit the (A/C) system inoperative with the Malfunction Indicator lamp (MIL) ON. This may be due the to Power Steering Pressure (PSP) switch terminal assembly becoming corroded causing the Powertrain Control Module (PCM) to open the A/C relay circuit and set DTC P0550. A modified PSP switch terminal assembly is available to resolve this concern.

Customers having this concern should have their vehicle repaired using the following procedure.


REPAIR PROCEDURE

- 1. Verify customer concern.
- 2. Turn the A/C system ON and disconnect the PSP switch.
 - If the A/C system does not function, refer to the workshop manual for troubleshooting and repair information.
 - If the A/C system operates, replace only the PSP switch <u>terminal</u> assembly.



Note

 Replace only the terminal assembly. Do not replace the entire PSP switch.



3. Verify repair.
